## New Structure of Volkswagen Financial Services Aktiengesellschaft and Volkswagen Bank GmbH

## Dear Funding Partners,

In the board meetings of Volkswagen Financial Services AG and Volkswagen Bank GmbH on March 01, 2023 the board approved the presented realignment concept of the Volkswagen Financial Services group. The final approval of the supervisory board of Volkswagen AG is to be expected on March 03.

Core elements of the new structure are:

- Establishment of a new "Volkswagen Financial Services AG" financial holding for the European financial services activities including the UK, which will be supervised by the ECB
- Volkswagen Bank GmbH and Volkswagen Leasing GmbH will be integrated and consolidated within this new European financial holding.
- Transformation of the existing Volkswagen Financial Services AG into a new "Volkswagen Financial Services Overseas AG", which will become the holding company of the non-European business activities
- The new structure is expected to be implemented by mid 2024.

With this realignment Volkswagen Financial Services paves the way for a successful implementation of the Volkswagen group strategy in the field of mobility services and encounters the changed regulatory environment. By realizing this new concept of two holding companies a sustainable refinancing structure for the ambitious growth path is secured.

Both holding companies will be 100% affiliates of Volkswagen AG and remain integral and strategic important parts of the Volkswagen Group. In the context of the realignment the existing domination and profit and loss transfer agreements will be adapted accordingly and extended to the new financial holding company.

Please rest assured that we will further strengthen the excellent and trustworthy cooperation with our national and international financing partners.
