Re: Fitch rating assignment regarding Driver Australia eight Trust

Fitch (see definition below) assigns the following ratings:

AUD650.3 million Class A notes (ISIN AU3FN0080743): 'AAAsf'; Outlook Stable; AUD51.0 million Class B notes (ISIN AU3FN0080750): 'A+sf'; Outlook Stable; and AUD41.2 million Subordinated Loan: 'NRsf'.

In issuing and maintaining its ratings, Fitch relies on factual information it receives from issuers and underwriters and from other sources Fitch believes to be credible.
