

Country-by-country reporting of Volkswagen Financial Services AG

The requirements pertaining to country-specific reporting, referred to as "country-by-country reporting" in accordance with Art. 89 of EU Directive 2013/36/EU (Capital Requirements Directive, CRD IV), have been transposed into German law as section 26a(1) sentence 2 of the Kreditwesengesetz (KWG – German Banking Act).

In this country-by-country reporting, the Volkswagen Financial Services AG Group discloses the following information as at December 31, 2014 pursuant to section 26a(1) sentences 1-6 KWG:

- > Company name, type of activity and geographic location of the branch
- > Sales revenue
- > Number of wage and salary earners in full-time equivalents
- > Profit or loss before tax
- > Taxes on profit or loss
- > State aid received

The report contains the required information for all fully consolidated entities included in the consolidated financial statements in accordance with IFRS. Branches are understood to be the individual subsidiaries and any branches maintained by subsidiaries in individual countries. The figures contained in this report were generally determined on an unconsolidated basis. Sales revenue was adjusted for intragroup transactions within a country.

Sales revenue is defined as the sum total of the following elements of the income statement in accordance with IFRS:

- > Interest income from lending transactions less interest expense
- > Income from leasing transactions and service contracts
- > Net commission income
- > Profit or loss from the measurement of derivative financial instruments and hedged items
- > Profit or loss from marketable securities and other financial assets
- > Other operating income

The reported taxes on profit or loss comprise effective income taxes. Please refer to the comments on income tax income/expense in the notes to the consolidated financial statements of Volkswagen Financial Services AG as of December 31, 2014 regarding the procedure.
