The Volkswagen Bank has developed appropriate business and customer-related safeguarding systems and controls (research / monitoring / smurfing / random samples) for the prevention of money laundering, terrorist financing and other criminal offences.

We periodically check the reliability of our employees. There are regular training courses for the entire staff.

We pay attention to the list of countries with a higher risk for money laundering and terrorism financing and the EU-embargo and financial sanctions as well as equivalent sanctions or measures imposed by the U.S. Office of Foreign Assets Control of the U.S. Department of the Treasury ("OFAC").

Annually Internal & External Audit check the safety measures concerning the prevention of money laundering, terrorism financing and other criminal offences.

Last year reports do not contain any serious complaints and confirm that the measures implemented are adequate and purposeful.
